#### **Torrance Elections**

Last month's newsletter included responses to two questions from the 3 TUSD Area E School Board candidates (Area E includes Southwood residents east of Anza Ave.). David Zygielbaum won the election with 51% of the vote. Tony Yeh came in second with 34% and Charles Deemer got 15%. TUSD Area E had a vacancy due to the election of Dr. Jeremy Gerson to the City Council. David Zygielbaum will finish out the remaining 2 years of the term.

Measure TC (Torrance City Council's proposed amendments to the City Charter) passed with 71% of the votes. As stated on the City website, Measure TC is designed to increase the efficient operation of city government, avoid potential corruption and mismanagement, and increase public transparency. It also increased the pay of City Council members from \$100/month to ~\$2,700/month (a full-time minimum wage salary).

#### **School Gifts**

Southwood HOA is proud to announce \$1,500 was gifted to both Anza Elementary and Jefferson Middle Schools in August 2024.

Anza Principal Catherine Di Vincenzo is again going to use the gift for Chromebooks as many of them are outdated/need repairs.

Jefferson Principal Lisa Nunes hopes to put the funds towards sunshade fixtures in the large courtyard.

# **New Senior Home Development Proposed**

Another living community is being proposed near the Southwood area. Anastasi Development Co. is proposing a 50-unit active senior condo community at 4501 Torrance Blvd. Recently, a 158-unit senior assisted living complex was completed (Cogir) near Carson St. and Del Amo Circle. Next door to Cogir, construction will soon begin on a 200-unit luxury apartment complex (Legacy Partners developer).

Anastasi's active senior condo community will be built on the site where the Brazilian Plate House, Via Firenze, and Thai Rama currently exist. The plan is for a 2 to 4 level tiered building with 50 units (38 two-bedroom homes and 12 one-bedroom homes).

- Approval of the second amendment to the employment agreement for the Superintendent of TUSD, Dr. Timothy Stowe.
- Adopt a resolution proclaiming November 2024 as Torrance Education Foundation Month.
- Adopt a Resolution recognizing November 18 22, 2024, as International Education Week.
