### **New Stop Sign**



A new stop sign was added on southbound Ocean Ave. at Carson St. just before reaching the service road as shown in the picture. Ed Candioty, who lives nearby, approached the City about the gridlock that occurs there before and after Jefferson school hours. Cars would fill up the service road intersection blocking traffic and making school children crossing unsafe. Hopefully, the new stop sign will keep the intersection clear.

## Paradise Park Upgrades

John LaRock, the City Community Services Director, shared plans for upgrades to Paradise Park.

- Torrance City Budget for 2024-25 includes a \$2,787,00 capital investment in Paradise Park.
- The scope of the project includes:
  - Replacement of the 2 playgrounds with new play equipment
  - Rehabilitation/replacement of the park restrooms, recreation room, and picnic shelter
  - Refurbishment of the wire frame play equipment
  - Resurfacing of tennis courts
- Over the summer, staff will hold community feedback sessions in the park for input on the playground equipment proposals.

### **SHA General Meeting Recap**

The Southwood HOA General Meeting took place on May 8 at Anza Elementary. After some meeting business, we honored our Scholarship winner, Kristen Sayano (see article above). We then had three Torrance Police Officers speak about issues particular to our neighborhood.

Motor Officer Stewart Scott addressed ebikes and traffic concerns. A resident brought up how cars speed down Ocean Ave. Officer Scott explained the City will not put in speed bumps as they slow down emergency vehicles. Officers address ebike issues by educating minors and, for repeat offenders, issue a citation which gets the parents involved.

Community Lead Officers Joe Craft and Jeff Clark reported the most common crime is thefts from vehicles. Thefts are when something is taken from an unlocked car. Burglary is when there is evidence of a break-in. So, lock your car doors and don't leave any valuables inside!

Homelessness was also discussed in light of a new court decision coming out soon that may allow enforcement of anti-camping ordinances. The myTorranceCA app may be used to request Homeless Outreach services.

#### **School Board Report**

The following is a brief summary of the April 16 and May 6 meetings of the Board of Education. The meetings are available to view in entirety on the TUSD website.

- As of April 10, due to the election of Dr. Jeremy Gerson to the Torrance City Council, our Board of Education has one vacant opening in Trustee Area E. The Board will temporarily fill the seat by provisional appointment. The selected appointee will serve until the consolidated special election takes place on November 5, 2024, to identify a candidate who will finish the following two years of the remaining term.
- Our Southwood neighborhood is split between Trustee Areas E and B.
   Area E includes the east part of the neighborhood between Anza and
   Ocean Avenue. The remainder of Southwood is in Trustee Area B.
   Jasmine Park, the current School Board President, resides in Area B.
   Her term expires December 2024. For more information regarding the

- Katherine Castleberry, TUSD Coordinator of Early Childhood Education, presented an update on the District's Preschool Expansion Plan. TUSD plans to expand beyond the current TUSD preschool program, which includes state preschool classrooms located at 6 elementary schools and a special education site at Arnold Elementary. The expanded preschool program will allow 3 year olds to attend preschool at their home schools. The plan is to offer full-day, feebased preschool at Walteria and Fern elementaries beginning in January 2025, and to open preschool classrooms at all Torrance elementaries within 5 years. The new program will also include placing students with disabilities in the general education preschool setting, and expanding the Dual Immersion program at Carr and Torrance elementaries to include preschoolers.

#### **Court Declares SB 9 Unconstitional**

Five charter cities – Carson, Redondo Beach, Torrance, Del Mar, and Whitter – initiated a lawsuit in early 2022 against the State of California claiming that Senate Bill 9 (SB 9) is unconstitutional and invalid against charter cities.

SB 9 requires all California cities to ministerially approve an application for a lot split, and up to four total housing units, on a single family residential lot that meets certain specified criteria.

On April 22, 2024, Superior Court Judge Curtis Kin determined that SB 9 is unconstitutional because it doesn't provide housing restricted for low-income residents, which he said was the law's stated purpose. The ruling clears the way for the law to be invalidated in cities across the state.
